



According to my records, a Campaign Finance Report was due from your political committee as of October 15, My records indicate that we received a copy of your report that you inaccurately sent to the Pinal County Elections Department, which they stamp dated, October 28.

The report would cover the period of July 1, 2021 to September 30, 2021.

If you received no contributions or made no expenditures during the period in which it is required to file a Campaign Finance Report, you may sign and file a form indicating no activity during the specific reporting period.

A campaign finance report and a no activity form are both included for your use. I'm also enclosing a Termination Statement in the event that you no longer wish to keep your political committee active. (You must have a .00 cash balance on your report in order to terminate).

ARS 16-918 requires our office to notify you that the report is past due and that a penalty of \$10 per day must be assessed, up to a maximum of \$450. Our office can not accept a Campaign Finance Report from you unless the penalties owed are paid with the report. (cash or money order only)

ARS 16-918 also states that if failure to pay/file within fifteen days after receiving this notice, you will be liable for a civil penalty of \$25 for each subsequent day that the filing is late.

Please complete the campaign finance report for the time frame stated and mail immediately with penalty of \$10 per day that the report is late; for a total of \$90.00 to:
