

Dear Parents (or Legal Guardian),

In response of your desire to instruct your child at home, I ask that you study the enclosed information. If you have any questions, which are not answered, don't hesitate to contact the county school office. It is our desire to help you comply with the law.

The law which establishes the criteria for parents or legal guardians, who wish to educate their children in their own home, may be found in Arizona Revised Statutes 15-802 and 15-828.

Arizona law requires that any parent or legal guardian of a child instructed at home submit an affidavit to the county school superintendent. The affidavit must be filed within 30 days after home instruction begins. A certified copy of the original birth certificate must be submitted along with the affidavit. However, if the original birth certificate is not available, the following will be accepted as reliable proof of pupil's identity and age: pupil's baptismal certificate, the application for a Social Security number, or original school registration records along with an affidavit explaining the inability to provide an original birth certificate.

The original affidavit must be notarized. It will be stamped with the date that it is received; a copy will be made and given back to you for your records.

No eighth-grade diplomas are available through the public school system for home study students. Accreditation requirements for all public high schools (grades 9-12) prohibit the public school district from giving units of credit toward public high school graduation for school work done under present Arizona home study laws unless the child passes specified tests at the local school district for courses for which credit is desired. The number of such credits accepted toward high school graduation will depend on the high school/district policy. The policies of any public school district can and should be reviewed by the parent/legal guardian PRIOR to removing child from school.

Attached is a list of the most common questions we have been asked by parents wishing to home school their children.

HOME SCHOOL AZ STATUT ES

15-802. School instruction; exceptions; violations; classification; definitions

A. Every child between the ages of six and sixteen years shall attend a school and shall be provided instruction in at least the subjects of reading, grammar, mathematics, social studies and science. The person who has custody of the child shall choose a public, private or charter school or a homeschool as defined in this section to provide instruction or shall sign a contract to participate in an Arizona empowerment scholarship account pursuant to section 15-2402.

B. The parent or person who has custody shall do the following:

1. If the child will attend a public, private or charter school, enroll the child in and ensure that the child attends a public, private or charter school for the full time school is in session. In accordance with guidelines adopted by the department of education, school districts and charter schools shall require and maintain verifiable documentation of residency in this state for pupils who enroll in the school district or charter school. If a child attends a school that is operated on a year-round basis, the child shall regularly attend during school sessions that total not less than one hundred eighty school days or two hundred school days, as applicable, or the equivalent as approved by the superintendent of public instruction.

2. If the child will attend a private school or homeschool, file an affidavit of intent with the county school superintendent stating that the child is attending a regularly organized private school or is being provided with instruction in a homeschool. The affidavit of intent shall include:

- (a) The child's name.
- (b) The child's date of birth.
- (c) The current address of the school the child is attending.

(d) The names, telephone numbers and addresses of the persons who currently have custody of the child.

3. If the child will attend homeschool, the child has not reached eight years of age by September 1 of the school year and the person who has custody of the child does not desire to begin home instruction until the child has reached eight years of age, file an affidavit of intent pursuant to paragraph 2 of this subsection stating that the person who has custody of the child does not desire to begin homeschool instruction.

C. An affidavit of intent shall be filed within thirty days from the time the child begins to attend a private school or homeschool and is not required thereafter unless the private school or the homeschool instruction is terminated and then resumed. The person who has custody of the child shall notify the county school superintendent within thirty days of the termination that the child is no longer being instructed at a private school or a homeschool. If the private school or homeschool instruction is resumed, the person who has custody of the child shall file another affidavit of intent with the county school superintendent within thirty days.

D. A person is excused from the duties prescribed by subsection A or B of this section if any of the following is shown to the satisfaction of the school principal or the school principal's designee:

1. The child is in such physical or mental condition that instruction is inexpedient or impracticable.

2. The child has completed the high school course of study necessary for completion of grade ten as prescribed by the state board of education.

3. The child has presented reasons for nonattendance at a public school that are satisfactory to the school principal or the school principal's designee. For the purposes of this paragraph, the principal's designee may be the school district governing board.

4. The child is over fourteen years of age and is employed, with the consent of the person who has custody of the child, at some lawful wage earning occupation.

5. The child is enrolled in a work training, career education, career and technical education, vocational education or manual training program that meets the educational standards established and approved by the department of education.

6. The child was either:

(a) Suspended and not directed to participate in an alternative education program.

(b) Expelled from a public school as provided in article 3 of this chapter.

7. The child is enrolled in an education program provided by a state educational or other institution.

E. Unless otherwise exempted in this section or section 15-803, a parent of a child between six and sixteen years of age or a person who has custody of a child, who does not provide instruction in a homeschool and who fails to enroll or fails to ensure that the child attends a public, private or charter school pursuant to this section or fails to sign a contract to participate in an empowerment scholarship account pursuant to section 15-2402 is guilty of a class 3 misdemeanor. A parent who fails to comply with the duty to file an affidavit of intent to provide instruction in a homeschool is guilty of a petty offense.

F. If a child will be educated pursuant to an empowerment scholarship account pursuant to section 15-2402, the department of education shall provide a list of students participating in empowerment scholarship accounts to the school superintendent of the county where the pupil resides.

G. For the purposes of this section:

1. "Educated pursuant to an empowerment scholarship account" means a child whose parent has signed a contract pursuant to section 15-2402 to educate the child outside of any school district or charter school and in which the parent may but is not required to enroll the child in a private school or to educate the child through any of the methods specified in section 15-2402.

2. "Homeschool" means a nonpublic school conducted primarily by the parent, guardian or other person who has custody of the child or nonpublic instruction provided in the child's home.

3. "Private school" means a nonpublic institution, other than the child's home, where academic instruction is provided for at least the same number of days and hours each year as a public school.

15-802.01. Homeschooled children; eligibility to participate in interscholastic activities

A. Notwithstanding any other law, a child who resides within the attendance area of a public school and who is homeschooled shall be allowed to try out for interscholastic activities on behalf of the public school in the same manner as a pupil who is enrolled in that public school. Registration, age eligibility requirements, fees, insurance, transportation, physical condition, qualifications, responsibilities, event schedules, standards of behavior and performance policies for homeschooled students shall be consistent with those policies established for students enrolled in that public school. The individual providing the primary instruction of a child who is homeschooled shall submit written verification that provides:

1. Whether the student is receiving a passing grade in each course or subject being taught.

2. Whether the student is maintaining satisfactory progress towards advancement or promotion.

B. A child who is homeschooled and who was previously enrolled in a public, private or charter school shall be ineligible to participate in interscholastic activities for the remainder of the school year during which the child was enrolled in a school.

C. A school district shall not contract with any private entity that supervises interscholastic activities if the private entity prohibits the participation of homeschooled children in interscholastic activities at public, private or charter schools.

15-828. Birth certificate; school records; exception

A. On enrollment of a pupil for the first time in a particular school district or private school offering instruction to pupils in any kindergarten programs or grades one through twelve, that school or school district shall notify the person enrolling the pupil in writing that within thirty days the person must provide one of the following:

1. A certified copy of the pupil's birth certificate.

2. Other reliable proof of the pupil's identity and age, including the pupil's baptismal certificate, an application for a social security number or original school registration records and an affidavit explaining the inability to provide a copy of the birth certificate.

3. A letter from the authorized representative of an agency having custody of the pupil pursuant to title 8, chapter 2 certifying that the pupil has been placed in the custody of the agency as prescribed by law.

B. If a child is instructed at home pursuant to section 15-802, the person who has custody of the child shall, within thirty days after the home instruction begins, provide to the county school superintendent of the county in which the child resides one of the following:

1. A certified copy of the child's birth certificate.

2. Other reliable proof of the child's identity and age, including the child's baptismal certificate, an application for a social security number or original school registration records and an affidavit explaining the inability to provide a copy of the birth certificate.

3. A letter from the authorized representative of an agency having custody of the pupil pursuant to title 8, chapter 2 certifying that the pupil has been placed in the custody of the agency as prescribed by law.

C. On presentation of a document pursuant to this section, a photocopy of the document shall be placed in the pupil's file and the document that is presented shall be returned.

D. A pupil shall be enrolled in the school or school district, or the county school superintendent shall record the pupil's name, using the name that is printed on the birth certificate, other reliable proof of the pupil's identity, or letter from an agency having custody of the pupil provided pursuant to this section. This subsection does not prohibit a school or school district from calling a pupil by any name the pupil's parent or guardian wishes the pupil to be called.

E. On the failure of a person enrolling a pupil or instructing a child at home to comply with subsection A or B of this section, the school, school district or county school superintendent shall notify that person in writing that, unless the person complies within ten days, the case shall be referred to the local law enforcement agency for investigation. If compliance is not obtained within the ten day period, the school, school district or county shall refer the case to the local law enforcement agency.

F. The school, school district or county school superintendent shall immediately report to the local law enforcement agency any affidavit received pursuant to this section which appears inaccurate or suspicious in form or content.

G. Within five school days after enrolling a transfer pupil from a private school or another school district, a school shall request directly from the pupil's previous school a certified copy of the pupil's record. The requesting school shall exercise due diligence in obtaining the copy of the record requested. Notwithstanding any financial debt owed by the pupil, any school requested to forward a copy of a transferring pupil's record to the new school shall comply and forward the record within ten school days after receipt of the request unless the record has been flagged pursuant to section 15-829. If the record has been flagged, the requested school shall not forward the copy and shall notify the local law enforcement agency of the request. School districts shall include in the educational records required by

this subsection data collected pursuant to sections 15-741 and 15-766, as prescribed by the state board of education.

H. Any disclosure of educational records by the school district or charter school shall comply with the family educational rights and privacy act of 1974 (20 United States Code section 1232g).

I. The provisions of this section do not apply to homeless pupils as defined in section 15-824, subsection C.



THE FOLLOWING IS PROVIDED AS A GUIDELINE FOR YOUR INFORMATION

Article 3. Curriculum requirements and special programs

R7-2-301. Minimum course of study and competency goals for students in the common schools

- A. Students shall demonstrate competency as defined by the state board-adopted essential skills, at the grade levels specified, in the following required subject areas. District instructional programs shall include an ongoing assessment of student progress toward meeting the competency requirements.
 - 1. Language Arts
 - 2. Literature
 - 3. Mathematics
 - 4. Science
 - 5. Social Studies
 - 6. Music
 - 7. Visual Arts
 - 8. Heath/Physical Education
 - 9. Foreign or Native American Language (includes modern and classical)
- B. Additional subjects may be offered by the local governing board as options and may include, but not limited to:
 - 1. Performing Arts
 - 2. Practical Arts
- C. Prior to the issuance of a standard certificate of promotion from the eighth grade, each student shall demonstrate competency, a defined by the local governing board, of the state board-adopted essential skills for grade eight in the areas listed in subsection (a).

MOST COMMONLY ASKED QUESTIONS REGARDING HOME SCHOOLING

Q: When will you or will you be testing?

A: Currently the state legislation has eliminated the testing requirement for home taught children.

Q: Do we provide the curriculum?

A: No

- Q: Where do I get the curriculum to teach my child(ren)?
- A: Check with local school districts or public library. You might also try new or used book stores. You can refer to the references listed in this packet as well.

Q: At what age am I required to file an affidavit for my children?

A: State law mandates that children between the ages of 6 and 16 be enrolled in some sort of educational environment. Parents are not necessarily required to file an affidavit for 6 and 7-year olds, but they do have to submit a letter indicating that they don't wish to send their children to school. However, at the age of 8, if a child is not enrolled in a public school, or an approved private or charter school, a home-schooling affidavit must be filed with the county school office.

Q: At what age am I no longer required to provide an education?

A: State law mandated that children between the ages of 6 and 16 be enrolled in some sort of educational environment. After the age of 16 an affidavit is no longer required. NOTE: A diploma is not available under the home-schooling Statutes. If a parent wants their child to receive a high school diploma, then communication should be developed between the parent and the local school district early in the child's educational career.

Q: What about a GED?

A: A student beyond the age of 16 may study for, and take the GED. Contact your local community college for testing dates. A study guide can usually be obtained from a college book store. You can begin your college classes with a GED and/or high school.

Q: Is "Home-Schooling" the same as "Home Bound"?

A: No. Home bound is a certain situation when a child has as illness or an accident and cannot get to school for a length of time. The school of enrollment is then required to provide the work and books and come to the home once or twice a week and teach, test, etc.

Q: What happens when I want to put my children back in school?

A: If you desire to put your child back into public school after having home taught, contact the school district of residence to notify them your child will be enrolling. There will be an evaluation of your child, which is subject to school policy and precedence. The school district may give your child a placement test to determine your child's appropriate grade level. If you desire to return your child to public school at grade 9 or above, a diploma may be difficult to obtain. Contact your local school district for more information.

Q: Can my child participate in sports at school?

A: Current Arizona revised statutes 15.802.01 reads: ".•. A child who resides within the at tendance area of a school and who is instructed at home shall be allowed to participate in interscholastic athletic competition on behalf of the public school in the same manner as a pupil who is enrolled in that public school...". Contact your local school district for more information and site AZ statute 15.802.01.

Q: What about non-athletic extracurricular activities?

A: Presently, the AZ statute does not require a school to permit home-school students to actively participate in non-athletic extracurricular activities.

Compulsory School Age in Arizona

When you start homeschooling (and when you get to stop)

Children must attend school or comply with the homeschool laws starting in the school year in which they turn 6 before September 1. They must remain in school until they turn 16 or complete the 10th grade. However, any child who has not reached 8 years of age by September 1 of the school year can be exempted from the compulsory attendance law if his or her parent files an affidavit with the county superintendent of schools stating that the child will not begin home instruction before turning 8.

HSLDA believes that a parent-issued diploma and transcript should be sufficient to demonstrate that a child has completed a secondary education. However, even if your child is beyond compulsory school attendance age, there may be situations where you would want to continue to follow the requirements of a home education option recognized under Arizona law until your child graduates from high school (filing a home education notice, keeping attendance and other records, etc.).

These records may be requested in some situations, such as obtaining a driver's license if your child is a minor, enlisting in the military, applying to colleges, or demonstrating eligibility for Social Security benefits. 

#1 - What is homeschooling?

Arizona state law defines a homeschool

Arizona Revised Statutes §15-802 G 2

"Homeschool means a nonpublic school conducted primarily

by the parent, guardian, or other person who has custody of the child or nonpublic instruction provided in the child's home."

Homeschoolers are parents or guardians who assume full responsibility for educating their children at home and must provide instruction in at least the subjects of reading, grammar, mathematics, science, and social studies pursuant to ARS §15-802.

Student Classifications

There are six general classifications of student in Arizona: Public School, Charter School, Virtual Charter School, Private School, Empowerment Scholarship Account (ESA contract student), and Homeschool.

Especially for at-home education options, there can often be confusion about whether a student is a homeschooler. While the schoolwork may take place at home, neither virtual charter school students nor ESA contract students are classified as homeschoolers according to Arizona Revised Statutes. Homeschooling is a legally defined option that is distinct from all other education options in Arizona.

#3 – What's required to homeschool in Arizona?

COMPULSORY ATTENDANCE AGE

Ages 6 to 16. Parents may elect to delay formal education until their child is 8 years old by noting so on the affidavit (must still file the affidavit at age 6).

ATTENDANCE

No minimum days required. Attendance tracking not required.

SUBJECTS REQUIRED

At least the subjects of reading, grammar, mathematics, science, and social studies. Parents select and purchase the curriculum and resources of your choice. Homeschooling allows you to move through material at a pace that works best for your child, and to customize the topics taught within each subject area.

TEACHER QUALIFICATIONS

None

NOTIFICATION

Submit a notarized Affidavit of Intent to Homeschool with proof of birth to the County School Superintendent's office within 30 days of starting to homeschool (or within 30 days of your child's 6th birthday if you started homeschooling earlier). The affidavit is filed once, not annually.

RECORD KEEPING / REPORTING

None required. Parents are responsible for creating their child's high school transcript and should keep records for 9th-12th grades to calculate GPA and complete the transcript.

STANDARDIZED TESTING

None required. There are a number of private testing services that homeschool families can utilize, if desired. Read more in our testing FAQ.

#4 - How do we get started?

#5 – What does it cost?

#7 – What about graduation?

The homeschooling parent is responsible for creating and maintaining their child's high school transcript and issuing a diploma. Students who are homeschooled through high school are able to successfully go on to college, the workplace, and the military.

AFHE Graduation Ceremony

Each spring (usually the end of May), AFHE hosts a beautiful cap-and-gown graduation ceremony for Arizona homeschool students graduating from high school at home. It is a special celebration of an important milestone and includes a commencement speaker, musical performances, senior class address, diploma presentation, photos of each graduate, and more. The registration window is mid-November through the end of February.

#8 - What about sports?

Arizona Revised Statutes §15-802.01 states that a homeschooled child who resides within the attendance area of a public school shall be allowed to try out for interscholastic activities (such as sports) on behalf of the public school in the same manner as a pupil who is enrolled in that school. Parents who choose this avenue should familiarize themselves with the policies of the Arizona Interscholastic Association (AIA).

There are a variety of opportunities available to homeschooled students within the homeschool community and in the private sector as well, including competitive athletics programs run by homeschoolers for homeschoolers, club ball organizations, programs offered through city parks and recreation departments, and more. One example of a competitive sports opportunity for Arizona homeschoolers is EVAC Sports.

#9 – What if my child is struggling or gifted?

Homeschooling can work really well for children who are gifted learners or who have special learning needs or unique learning challenges of all types. Parents can offer their children individualized education, flexibility, encouragement, and support. #10 – What about socialization?

Socialization is defined as "to make fit for companionship with others; make sociable." Many homeschooling families have discovered that healthy socialization takes place when children are exposed to people of all ages in various settings, rather than being limited to a group of peers all about the same age. Children can learn to socialize in everyday activities such as a trip to the grocery store or library, visits with grandparents, play dates with friends, support group activities, park days, and so on. More importantly, children often receive their most valuable socialization in the nurturing environment of home and family.

Arizona has a vibrant, active homeschool community with many opportunities for socialization. One of the biggest challenges families encounter is dealing with the abundance of activities available. Parents should look for activities that enhance the homeschool experience without leading to the frenzied distraction of too many outside endeavors. Learning to say "no" to the good and the better helps a family leave room for the best.

How Do I Get Started?

HOW DO I REGISTER MY CHILD?

Complete an Affidavit of Intent to Homeschool. Have it notarized. Make a photocopy for your records. Mail the original signed and notarized Affidavit to your County School Superintendent's office along with proof of birth. The County will mail the original birth certificate (or other proof of birth) back to you once they have made a photocopy. Or you may hand deliver the affidavit and birth certificate to the County School Superintendent's office, where they will receive and file your affidavit and make a photocopy of the birth certificate, returning the original to you.

WHERE DO I GET AN AFFIDAVIT OF INTENT TO HOMESCHOOL?

You can print an Affidavit of Intent to Homeschool in pdf format from the AZ LAW page.

WHEN DO I NEED TO FILE THE AFFIDAVIT OF INTENT TO HOMESCHOOL?

The Affidavit of Intent to Homeschool must be filed within 30 days of starting homeschooling for children ages 6-16. You may delay the start of formal education of your child until age 8 by noting so on the affidavit. If you decide to delay formal education until age 8, you would still file the affidavit with the County when your child turns 6.

WHAT IF I AM REMOVING MY CHILD FROM A PUBLIC OR PRIVATE SCHOOL?

There is no formal process or specific form that must be completed, but we recommend

removing your child to educate them at home.

DO I NEED TO JOIN A HOMESCHOOL ORGANIZATION?

You are not required to join any organization in order to homeschool. However, there are several that may be beneficial to you.

- 1. AFHE (Arizona Families for Home Education) By joining the state homeschool organization, you will be kept abreast of legislative issues that may affect homeschoolers in Arizona as well as other helpful information in the quarterly magazine Homeschool Arizona and periodic email updates sent to AFHE members who subscribe to our email list. Your AFHE membership supports an organization that serves Arizona homeschoolers all year long and is actively watching legislation that may affect homeschool freedom in our great state.
- 2. HSLDA (Home School Legal Defense Association) Members of HSLDA receive professional legal representation to protect the right to homeschool. HSLDA also acts as a voice for homeschooling families nationwide and monitors all state legislation that could reduce our homeschooling freedoms. AFHE members receive a discount on their HSLDA membership.
- 3. Local Support Group membership is a great way to connect with other homeschooling families in your area, to share ideas, to encourage, edify and equip one another in the incredible homeschooling journey. AFHE maintains a list of homeschool support groups statewide as a reference. Please visit the SUPPORT GROUPS page to see what groups are available in your area.

HOW DO I FIND CURRICULUM?

There is an abundance of curricular resources available. You can search the Internet, talk to other homeschoolers, and attend the annual home education convention hosted by AFHE. At the convention you can browse the exhibit hall and attend vendor workshops to learn more about their products.

your child to identify the way they learn best (auditory, visual, hands-on, etc.). There are many books on the market that can help you do this. *The Way They Learn* by Cynthia Ulrich Tobias is a good example. Identifying your child's learning style can help you choose the best curricula for your child.

TALK TO OTHER HOMESCHOOLERS – Talk to parents who have been homeschooling awhile. Talk to parents who have children similar to yours. Ask them what works well for them and why. Ask them what they have tried that they didn't like and why.

BE WILLING TO TRY DIFFERENT THINGS – It is important to understand that there may be some "trial and error" involved in choosing curriculum that will work well for your individual children and your family. This flexibility and ability to customize your student's program are great advantages of homeschooling!

READ HOMESCHOOL GUIDES – Read books that describe various curricula and resources such as Mary Pride's **Complete Guide to Homeschooling** series, Cathy Duffy's **102 Top Picks for Homeschool Curriculum: Choosing the Right Curriculum for Your Child**, and Carol Barnier's **The Big WHAT NOW Book of Learning**.

WHAT SUBJECTS DO I HAVE TO TEACH?

In Arizona, we are required by law to provide instruction in at least the subjects of reading, grammar, mathematics, science, and social studies. What you specifically teach for each subject, when you teach it, and at what pace you move through the material is up to you as your child's teacher.

WHAT ABOUT STANDARDIZED TESTING?

In Arizona, there is no standardized testing requirement for homeschooled students (including the AzMERIT test). It is up to the individual parent/family whether or not to do standardized testing. One benefit to doing periodic standardized testing is that it gives FHE START HOMESCHOOLING ~

HOW LONG SHOULD WE SPEND DOING SCHOOL EACH DAY?

It takes less time than you may think, especially in the elementary years. In the one-onone tutorial setting of a homeschool, seatwork can be completed in a relatively short amount of time. This leaves plenty of room in the day for creative play, experiments, projects, exploration, reading, music, time with friends, and much more. Remember, homeschooling is more than an educational option, it is a way of life. Learning doesn't take place only when your child is doing a workbook. True learning can take place all day, everyday, and in every activity.

Testing

This section answers questions about standardized testing, college entrance examinations, and the GED.

Standardized Testing FAQs

WHAT ARE THE BENEFITS OF STANDARDIZED TESTING?

Periodic testing gives your students practice taking norm-referenced "fill-in-the-bubble" tests. It can provide a reliable measure of your child's performance as compared with other students their age throughout the nation.

IS MY HOMESCHOOL CHILD REQUIRED TO TAKE STANDARDIZED TESTS?

No. In Arizona, there is no standardized testing requirement for homeschooled students including the AzMERIT test (formerly the AIMS test). It is up to the individual parent/family whether or not to do standardized testing through a private source. If you wish to have your child take a standardized test, check with your local homeschool support group to see if they offer testing. If they do not, there are several vendors offering testing materials that you can purchase.

ARE THERE OTHER WAYS TO EVALUATE MY CHILD'S PROGRESS?

Daily observation as well as tests found in your child's curriculum are two excellent means of monitoring and evaluating your student's progress. Through the one-on-one interaction between parent and child, a parent observes how well their child is learning a specific body of knowledge and skills.

IF I DECIDE TO HAVE MY CHILD TAKE A STANDARDIZED TEST, WHERE DO I GO?

Standardized tests are available for purchase by homeschooling families through independent suppliers.

A number of local homeschool support groups across Arizona do offer testing in the spring for their member families. If you wish to have your child take a standardized test, check with your local homeschool support group to see if they offer testing. Covenant Home School Resource Center in Phoenix also offers testing in the spring.

AFHE does not recommend that homeschooled students take the AzMERIT test (formerly the AIMS test). There is no benefit for a homeschooled student to take this

UNDERSTANDING THE HISTORY OF HOMESCHOOL STUDENTS AND STANDARDIZED TESTING IN ARIZONA January 25, 2007: AFHE Response to Maricopa County Superintendent's Offer of AIMS Testing

On January 22, 2007 The Arizona Republic reported that a letter had been sent to all parents of students for whom their office has registered an Affidavit of Intent to Homeschool in Maricopa County. This letter invited parents to bring their children voluntarily to their Central Avenue office for AIMS testing in late February extending through April 2007.

AFHE discourages parents from accepting this offer for the following reasons:

1) A.R.S. 15-745(a) states: "Nothing in this article shall be construed to require the testing of children who are instructed in a homeschool program while they are receiving homeschool instruction." You are not required by law to take the AIMS test. Many home educators do privately test their children to help them plan their curriculum goals. Our website has links to private testing resources. We encourage parents to use these tests for their evaluation purposes.

2) Maricopa County School Superintendent's office has no accommodation so that parents may pay for the cost of this testing directly. Therefore, using this service is at a cost to the taxpayers. Entangling private home education with taxpayer money will inevitably lead to loss of freedom to home school. No assurance that the testing results will be the sole property of the parents is made with this offer. Whether another governmental agency may obtain access to the information is not clear. Any service has attendant costs and this test is no different such as costs of creation, printing, administration, proctoring and grading.

RESOURCES ~

A.R.S. 15-745. We won the right to be free from mandatory testing as home educators and placed the decision regarding testing in the control of parents. We believe that if parents voluntarily submit to this offer of "free" testing it will reopen the debate over mandatory testing once again. We ask that those secured rights be valued and protected by all who enjoy the freedom to homeschool in our state.

4) The assertion that colleges are requiring the AIMS test is inaccurate. AFHE works with all three state universities and they accept homeschooled students based upon an SAT or ACT score and a carefully prepared transcript that details the high school course of study. As far as out-of-state colleges, the AIMS test is an Arizona instrument only.

AFHE has always had an excellent relationship with our Maricopa County School Superintendent, Dr. Sandra Dowling and her dedicated staff. We understand their belief that they must offer this service. However, we must agree to disagree on the wisdom of homeschooling parents availing themselves of this offer, citing our concerns listed above.

GED FAQs

Taking the GED can be a controversial issue in the homeschool community. A diploma earned by taking the GED tends to carry the stigma of indicating a "high school dropout." It is not necessary for a homeschooled student to get an accredited diploma and it isn't generally recommended to get the GED.

In Arizona, one must be age 18 or older to take the GED test. For homeschooled students between the ages of 16 and 18, verification that they have withdrawn their Affidavit of Intent to Homeschool must be provided. Rules for taking the GED in Arizona can be found on the Arizona Department of Education website.

The parent of a homeschooled child is responsible for setting the graduation requirements, creating and maintaining their child's transcript, and issuing the diploma. AFHE does not issue diplomas or validate your homeschool diploma.

certifying the student's status as a graduate. Thorough documentation of a student's academic record on a transcript supports the diploma.

WHERE CAN I PURCHASE A DIPLOMA?

IS THERE A GRADUATION CEREMONY FOR HOMESCHOOLED GRADUATES?

AFHE sponsors an annual statewide Graduate Recognition Ceremony for homeschooled seniors each year. The AFHE Senior High Graduate Recognition Ceremony is a very reverent, formal cap and gown ceremony that commemorates the achievement of the students and their parents. Arizona:

Arizona homeschool or private school students may be eligible for special education services provided by their school district for free. The state considers homeschooled students as privately schooled students for purposes of determining access to special education services.

Alternatively, parents of homeschooled children can apply for Empowerment Scholarship Accounts (ESAs), which allow parents to access 90% of the funding their district would have received for their child. Parents who receive ESAs cannot access special education services from their local districts, but can have educational expenses for their child reimbursed from the ESA. Families of students wishing to access special education services through their district should contact their local district. Parents of students wishing to use the ESA option can find more information and apply at the Arizona Department of Education.
