Recently I was quoted as saying the high school district dropped its auto program. After making the statement, I found out the program still exists because our community has supported the budget overrides for both our school districts.	
The funding that we provide both districts allows them to attract highly qualified staff and offer various opportunities to help students discover their sparks. Research says that for students to thrive, they must know their spark, have an adult relationship to cultivate it, and have a voice. Only about seven percent of US citizens reported having all three present in their lives before COVID, and one in three reported having none of the three present.
