**RESOLUTION**

**RESOLUTION APPROVING THE ARGUMENT OF THE GOVERNING BOARD OF ORACLE ELEMENTARY SCHOOL DISTRICT NO. 2 OF PINAL COUNTY, ARIZONA, IN CONNECTION WITH THE DISTRICT'S SPECIAL MAINTENANCE AND OPERATION BUDGET OVERRIDE ELECTION; AND RATIFYING ALL ACTIONS TAKEN OR TO BE TAKEN TO FURTHER THIS RESOLUTION.**

**WHEREAS**, Oracle Elementary School District No. 2 of Pinal County, Arizona (the "*District*"), has ordered and called a special election to be held in and for the District on November 7, 2023 to submit to the voters the question of authorizing the District to continue to exceed its applicable revenue control limit by fifteen percent (15%) for a period of seven (7) years (the "*Election*"); and

**WHEREAS**, pursuant to Arizona Revised Statutes § 15-481.B.9, the Governing Board of the District (the "*Board*") shall prepare a written "for" argument in support of the proposed increase in the budget to be contained within the informational pamphlet; and

**WHEREAS**, by this Resolution, the Board shall approve and cause to be signed by the Board the written argument "for" the Election; and

**NOW, THEREFORE, IT IS RESOLVED BY THE GOVERNING BOARD OF ORACLE ELEMENTARY SCHOOL DISTRICT NO. 2 OF PINAL COUNTY, ARIZONA, AS FOLLOWS:**

**Section 1.**     **Approval.**     The Board hereby approves the argument "for" the Election attached hereto as *Exhibit A* and causes the same to be signed by the Board and submitted to the Pinal County School Superintendent for inclusion in the informational pamphlet.

**Section 2.**     **Ratification of Actions.**     All actions of the officers and agents of the District which conform to the purposes and intent of this resolution are hereby ratified, confirmed and approved. The proper officers and agents of the District are hereby authorized and directed to do all such acts and things and to execute and deliver all such documents on behalf of the District as may be necessary to carry out the terms and intent of this resolution.
